Benefits and Work for Disabled People

Course Aims

This course aims to promote employment for disabled adults by providing an overview of how the benefit system affects disabled adults who are in or entering work. The course will identify how work and earned income affects the benefits that disabled adults claim. The course aims to help participants maximise the entitlement for those that they support who have, or are moving into, paid employment.

Course includes

- Disability Living Allowance
- Carers Allowance
- Employment and Support Allowance
- Incapacity Benefit & Income Support
- Severe Disablement Allowance
- Housing Benefit & Council Tax Benefit.
- Working Tax Credit
- "permitted work" rules within Employment and Support Allowance and Incapacity Benefit/Income Support and incentive schemes that are designed to ease the path back to work such as Housing Benefit 4 week run on.
